## School Board Information

As an Independent Public School, the school is expected to have a School Board.

The Principal is responsible for the educational leadership, operation and management of the school.

The role of the School Board is one of setting the long-term future for the school and maintaining

oversight (not management) of the School Business Plan. It is not about running the school that is the job of the Principal, but rather, about providing additional expertise and community voice to help the school achieve the best outcomes for students. The role of the School Council (board) is outlined in the Education Act 1999.

## Appointment to the Board

- Current Board members are on the school website.
- The school Principal is automatically appointed to the School Board,
- The school staff will elect three staff representatives to the School Board,
- The school community will elect five parent representatives to the School Board,
- The school Principal may invite a community/business/eminent representative to be on the School Board.

The school community will elect the three representatives based on nominations through an 'Expression of Interest' to the Principal.


The 'Expression of Interest' should include a brief statement about the candidates interest in becoming a School Board member and their skillset, knowledge and commitment to the role.

## Responsibilities of the School Board

- Work within the Department of Education's relevant legislation and regulations;
- Contribute to the school's Delivery and Performance Agreement (DPA);
- Monitor the progress of the school's Business Plan;
- Endorse and review the annual budget and School Funding Agreement;
- Assist with the formulation of the Codes of Conduct;
- Participate in the review of the school;
- Create interest, within and across the community, about the school;
- Assist with the selection of the principal when a vacancy arises (usually the Chair of the School Board will be a member of the panel);
- Approve fees, charges, contributions and items of personal use;
- Approve extra cost optional components of programs;
- Approve arrangements for sponsorship or advertising;
- Liaise with other committees within the school
- Hold one open meeting each year to report to the school community;
- Provide advice to the principal on religious education and related activities.

## Board Members

When considering becoming a member of the School Board, you should understand the board's strategic role of oversight, direction and advice is distinct from the role of the Principal who is responsible for the educational leadership and day to day management and operations of the school.

It is vital you keep informed about the business of the board and be able to make conscientious and informed decisions. You will follow the lead of the board chair and be aware of expectations of your conduct regarding board matters. You will need to work constructively and cooperatively with other board members.

Your primary obligation is to support the agreed strategic direction and priorities of the board. School Board tenure has a maximum of three years. You must also commit to attending one of two meetings a Term (Weeks 4 & 8) on a Wednesday from 5-6.30pm.
